Intro, Bible, Theology, & BCO

Introduction & Procedures

I. REQUIREMENTS. According to the Book of Church Order (BCO 24-1), Ruling Elder candidates "shall receive instruction in the qualifications and work of the office. Each nominee shall then be examined in:

- a. his Christian experience, especially his personal character and family management (based on the qualifications set out in 1 Timothy 3:1-7 and Titus 1:6-9),
- b. his knowledge of Bible content,
- c. his knowledge of the system of doctrine, government, discipline contained in the Constitution of the Presbyterian Church in America
- d. the duties of the office to which he has been nominated, and
- e. his willingness to give assent to the questions required for ordination (BCO 24-5)."

II. INSTRUCTION & EXAMS. To fulfill these requirements, you have already been asked to fill out a personal qualifications Questionnaire, be interviewed by the Session, and attend the training class. Additionally, you will need to take the following three written exams contained in this packet:

- I. Bible (Knowledge of Bible Content)
- 2. Theology (System of Doctrine in the Westminster Standards)
- 3. Government & Discipline (Book of Church Order)

III.VOWS. Furthermore, you should reflect upon the following vows which you will be asked to take if/when you are ordained as a Ruling Elder (BCO 24-6):

- 1. Do you believe the Scriptures of the Old and New Testaments, as originally given, to be the inerrant Word of God, the only infallible rule of faith and practice?
- 2. Do you sincerely receive and adopt the Confession of Faith and the Catechisms of this Church, as containing the system of doctrine taught in the Holy Scriptures; and do you further promise that if at any time you find yourself out of accord with any of the fundamentals of this system of doctrine, you will, on your own initiative, make known to your Session the change which has taken place in your views since the assumption of this ordination vow?
- 3. Do you approve of the form of government and discipline of the Presbyterian Church in America, in conformity with the general principles of biblical polity?
- 4. Do you accept the office of ruling elder (or deacon, as the case may be) in this church, and promise faithfully to perform all the duties thereof, and to endeavor by the grace of God to adorn the profession of the Gospel in your life, and to set a worthy example before the Church of which God has made you an officer?
- 5. Do you promise subjection to your brethren in the Lord?
- 6. Do you promise to strive for the purity, peace, unity and edification of the Church?

I. BIBLE EXAM Knowledge of Bible Content

General Instructions: This exam is <u>open book.</u> You should feel free to use any books or sources (including a reference Bible) when you take this examination. There is no time limit to this exam, but please try to make your answers succinct, yet as clear as possible.

Try to respond to each question in your own words, but feel free to quote from the actual language of the Standards if it clarifies your meaning.
